## Q: How many homes are being leased?

## Q: When will the vote be completed?

A: Approval by a total of 2/3 (67%) of GHA members in good standing is required for the amendment to be approved.

## Q: When will Amendment process be completed?

A: Additional signatures are required to reach to total of 46 approval votes to pass the amendment. Board members will obtain these signatures via houseto-house solicitation with preference given to members in good standing. It is expected that this process will be completed within the next 2 weeks. A follow-up communication will be sent to all GHA members on our Roster to update the status of this process.
